

**Agreement of cooperation  
between Polish Agency for Enterprise Development  
and  
Ukrainian Fund for Enterprise Support**

**Polish Agency for Enterprise Development and Ukrainian Fund for Enterprise Support**  
hereinafter called the “Parties”

regarding the importance of the economic cooperation, stimulation of market relations development, market formation and saturation with goods and services,

in order to give a new impulse for bilateral cooperation between Republic of Poland and Ukraine on the basis of equal rights and mutual benefits have agreed as follows:

**Article 1**

The Parties will cooperate in the area of enterprise promotion in accordance with the national legislation of both Parties and within their authorities.

The Parties will support the development of mutually advantageous economic and partnership relations among institutions acting for the enterprise development in Poland and Ukraine as well as Small and Medium Enterprises entities from both Parties countries.

**Article 2**

1. In order to realize the mutually advantageous cooperation, the Parties will exchange their experience and best practices in the scope of:

- a) the development of small and medium enterprises,
- b) the export of goods and services,
- c) the regional development,
- d) using new techniques and technologies,
- e) making new jobs,
- f) counteracting the unemployment and developing human resources,
- g) providing the conditions of free access for new entities running the business on the market,
- h) financial-credit and investing support for small and medium enterprises.

2. The Parties will render accessible information on the national legislation of both Parties in the scope of supporting small and medium enterprises as well will exchange other information materials being in the interest of both Parties, particularly information materials on structures and organizations cooperating with small and medium enterprises in the scope of regulations and controls, taxation, consultations, etc.

3. The Parties will disseminate the results of research and the achievements in the areas being the subject of cooperation between the Parties by hand of various publications.

### **Article 3**

The Parties will exchange information on transfer of innovations and technologies.

### **Article 4**

The Parties will be involved in organizing and carrying out joint seminars, meetings and conferences with the participation of the representatives of enterprises and institutions supporting the enterprise development in the Parties countries.

### **Article 5**

The Parties will inform and encourage the representatives of enterprises and institution supporting the enterprise development to actively participate in international, national and specialist conferences, fairs and other undertakings organized in the territory of the Parties countries.

### **Article 6**

This Agreement may be subject to changes and supplemented with the consent of both Parties. The changes shall be introduced in the form of individual annexes and come into effect in accordance with Article 8 of this Agreement.

### **Article 7**

Doubts rose in relation with the application or interpretation of provisions of this Agreement will be solved by both Parties through consultations and negotiations.

### **Article 8**

1. This Agreement will come into force from the day of its signing by both Parties.
2. The Agreement will expire after 3 months from the day of receiving the written notice by one of the Parties about discontinuing the execution of this Agreement. The expiration of

the Agreement will not influence projects, programmes and other undertakings realized by the Parties and initiated in accordance with the provisions of this Agreement and not completed until the day of discontinuing its execution as well as contracts and agreements negotiated in order to execute this Agreement unless Parties decide otherwise.

This Agreement has been made in .....*Kiev*..... on *07 June*.... 2007 in two copies, each in Polish, Ukraine and English language whereof all texts have the same legal effect.

If any disputes regarding the interpretation of this Agreement occur, the Parties will refer to the text in English language.
